Nominated contractors and organizations must be members of NRCA. Self-nominations are not accepted, and a nominator cannot be employed by the roofing contracting company being nominated. However, nominated companies may help in the preparation of the entry to ensure adequate information is provided.

Nominations will be accepted from:

- Building owners and facility managers
- Design professionals and roof consultants
- NRCA affiliate executives
- Insurance companies
- Manufacturers and distributors

ENTRY PREPARATION

A nomination package should consist of the following:

An official nomination form (see other side).

Description of the project, program, service or event. In addition to the nomination form, on a separate sheet, please describe what made the project, program, service or event so unique that it should be considered for a Gold Circle Award. Be sure to provide adequate details explaining the project from its conception to completion.

Descriptive photographs. Descriptive photographs must be submitted for entries in the workmanship and innovative categories. Photographs, booklets, etc., are recommended and encouraged for all categories if applicable.

Other relevant entry materials. Include other relevant items to explain the project from beginning to end. Please remember the only information the judges will have to make their decision is the information and pictures received with the entries.

Package entries carefully. Applicants are responsible for shipping-related costs. All entries become the property of NRCA. Do not send irreplaceable materials.
