- 5+ years of industry experience preferred
- Be knowledgeable of his or her company's structure, operations, and financial and accounting methods
- Have increasingly responsible management experience
- Be at least 25 years old

(NOTE: The sponsor's role is to recommend the student for the program; be a mentor to the student and then monitor the student's progress along the way.)

* More than one student from the same company may apply to the program as long as each works in a different physical operation. However, it is not preferred. The success of the FEI experience is rooted in a student's ability to comfortably share thoughts and questions without hesitancy; therefore, two people from the same company and same location will not be accepted into the same class. A second candidate from the same company only will be considered if there are seats available. As such, these candidates are subject to an interview by the FEI Admissions Committee.
